SCHOOL HEALTH COLLABORATIVE - 2024 QUARTER 3 SESSION

WELCOME AND OVERVIEW

Funded by the Federal Centers for Disease Control and Prevention (CDC) Healthy Schools Grant, Stellar Group has been subcontracted through RMC Health to facilitate the School Health Collaborative (the Collaborative) through June 2025. This session of the Collaborative is the Quarter Three 2024 meeting. The session began with an overview of the agenda:

PANEL ON NALOXONE KIT IMPLEMENTATION

Panelists

The four panelists (listed above) offered their expertise on the implementation of <u>HB 202</u>. Pat Sidmore touched on the naloxone administration virtual training offered through DEED; Tim Easterly discussed details of kit distribution to school districts across Alaska; Wendy Williams shared the school nurse perspective; and Shirley Sakaye gave a presentation on DOH's marketing plan for promoting naloxone kits information across Alaska.

The implementation of HB 202 has been a coordinated effort across DEED and OSMAP (DOH). DEED has prioritized naloxone kit training to school administrators while OSMAP has prioritized naloxone kit distribution. To date, OSMAP has distributed naloxone kits to all 54 school districts. Now that kits are distributed, OSMAP is shifting priorities to move into establishing lines of communication and feedback loops regarding kit use, replacements, expiration dates, etc. As it stands, OSMAP will communicate with district representatives, who will be responsible for relaying information to administrators within their district/schools, and vice versa. Most importantly, district representatives will need to report to OSMAP when kits

are used. Communication will include encouraging school administrators, educators, and students to take advantage of DEED's training. One benefit of using DEED's eLearning platform to administer trainings is the ease of data collection through the site.

DOH has been working on supporting school staff and the reach of this bill across Alaska. Specifically, Wendy Williams is supporting school nurses and Shirley Sakaye is directing DOH's messaging of the bill. DOH is ensuring that distribution and training on the naloxone kits coincide with the national medication administration standards that school nurses are required to follow for their RN licensure. Fortunately, HB 202 provides training education for school staff, and DOH has access to other state resources through the National Association of School Nurses. School nurses provide care for 77% of Alaska's school aged children. For the 23% of students with no access to school nurses, there are opportunities to collaborate with School Based Health Centers and Community Health Centers for naloxone education, training, and potential administration (a rural school safety and health community of practice will begin this Fall). Under the guidance of Commissioner Hedberg, DOH is promoting a unified marketing campaign to promote HB 202. The campaign involves pushes via social media and ads in airports, on public transportation, and posters. The messaging revolves around an immediate response for kit distribution and training, overdose prevention and education for families and providers, and stories surrounding treatment and recovery, focusing on destigmatization and stories from youth. Websites are currently being updated, but more information will be found at opiods.alaska.gov and findtreatment.org.

Once panelists spoke, discussion arose around using the Collaborative to make connections with individuals and departments to continue to broadcast naloxone kit training, education, and messaging. Specifically utilizing Schools Specialists and DOH tobacco group as a resource for promoting information in rural Alaska and communicating with after school programs about HB 202. There is also opportunity for the Collaborative to utilize the CDC health teachers and principals survey to brainstorm Alaska specific questions for the 2025 survey to ask about naloxone kit implementation (and other questions).

PRIORITIES AND GOALS FOR THE COMING YEAR

Throughout the panel it was discussed that the Collaborative is a useful space for the sharing of information. A mural board was shared with a visual of the Collaborative's mission statement and how DEED and DOH can have overlapping priorities. Participants shared other groups outside of DEED and DOH who are essential collaborators to promote the links between health and academics: Advisory Board on Alcohol and Drug Abuse, Alaska Mental Health Board, Association of Alaska School Boards, Council on Domestic Violence and Sexual Assault, Department of Public Safety, Department of Transportation, SERRC, Alaska's Educational Resource Center, Statewide Suicide Prevention Council. This spurred reflection on the mission statement of the Collaborative (written when the Collaborative began in 2012) and its current relevancy.

School Health Collaborative Shared Mission:

"It is important that all programs affecting school and student health, whatever the subject matter, have shared school health messaging promoting the link between health and academics." The Collaborative has evolved since its inception over a decade ago, but it remains a space for connection, information sharing and *collaboration*. Participants feel strongly about using the space for Alaska State Departments to connect and provide support on initiatives and programming activities, share ideas and information on projects, support different Department's work towards core Alaska goals, and provide a collaborative space for various funding sources.

For the coming year, a pre-meeting poll was distributed to Collaborative members on September 13th prior to the session to learn about the key priorities and topics of attendees. The results for the poll were:

- » How Alaska can best use the 2023 Youth Risk Behavior Survey data
- » Mental and behavioral health in schools
- » Alaska Health Education Standard update
- » School Health Profiles data use
- » Children and youth with special health care needs in Alaska program
- » Substance use: tobacco, vaping, smoking
- » Social media and cell phone use in schools: data, policy, etc.
- » Chronic disease and injury prevention and education (diabetes, TB, etc.)
- » Physical education, health education, and support for health educators
- » School Based Health Centers
- » Youth Alliance for a Healthier Alaska (YAHA) panel

Most importantly, the collaborative needs to hold time and space for discussion of any immediate current events/topics. The potential topics for discussion are extensive and ever growing.

LOOKING FORWARD: 2023 YRBS DATA BRAINSTORMING

Jenna Test, YRBS manager for AK DOH, shared an update on the data analysis and sharing of the 2023 YRBS results. <u>2023 Statewide YRBS dashboard</u> is available, with district level data to be released in the coming weeks. Although 2025 YRBS questions had to be submitted to the CDC in August, moving forward the Collaborative can be a space for developing future questions for the survey, and will be essential for assisting the cross-analysis of data to inform projects and programs across DEED and DOH. The next big topic will be how to broadly share the YRBS data with Alaska.

YOUTH RISK BEHAVIOR SURVEY UPDATE - JENNA TEST

The 2023 <u>YRBS statewide dashboard is now available.</u> It is anticipated that the district level data will be released later this fall. Any data requests can be submitted <u>here</u>. We are gearing up for the 2025 survey. AK suggestions and edits to the questionnaire have been submitted, and we are awaiting final approval from the CDC. Once obtained the questionnaire will be posted to our <u>website</u>. The 2025 survey will be administered electronically. We are hopeful electronic administration of the survey will reduce some of the burdens associated with administrating the survey for school staff and will make it easier for students to participate.

ADOLESCENT HEALTH STRATEGIC PLANNING- LINDSAY HAMMER

The SOA Adolescent Health program will be wrapping up strategic planning end of this month and will hopefully have published documents ready by end of October for the community and partners, as well as a clearer path forward in aligning the AH program with Alaska's needs.
